

APPLICATION FOR NATURAL GAS SERVICE

I hereby make application to Gibson County Utility District, Gibson County, Tennessee, to be supplied with gas service at the following premises:

and I agree to take and pay for such in accordance with the schedule of rates, rules, and regulations of the Gibson County Utility District (GCUD).

I hand you herewith payment with my request to connect to the system as soon as gas service may be available. The service may not extend more than 3 feet past the nearest corner of the house. All service line footage will be paid by me at the utility's current rate per foot. The meter location will be at the direction of GCUD. When a service line serving only one residential customer is installed or replaced, Section 192.383 of the Pipeline Safety Regulations requires the District to install an excess flow valve on that service line.

GCUD agrees if it is not able to provide gas service to me within 18 months after date of this application, the above payment will be repaid to me in full but if service is available within the above period the payment/connection fee will be retained by the gas company.

I further agree to adhere to the current International Fuel Code of installation as required by GCUD

I hereby authorize and direct GCUD to go on my premises for the purpose of installing said gas service line from the gas main to the buildings; and to make all necessary excavations on my premises for laying said service line. I understand that the Utility District will make every effort to leave the premises in a reasonable condition upon completing the excavation. The Utility District will not be responsible for property restoration after gas service has been completed. GCUD will provide material, labor and product as agreed upon by Customer. GCUD is not responsible for incidental damage to grass, sod, dirt, shrubs, etc. as some damage may occur to those items in the natural process of ingress to building site and during the installation process. **Customer shall be responsible for locating all underground utilities owned by the Customer- gas lines, water lines, sewer/septic systems, dog watch lines, etc. Homeowner will be responsible for the cost of all repairs to said items should damage occur.**

Employees of said GCUD are granted the privilege of going on my premises for the purpose of making all necessary inspections, maintenance operation and repairs and meter readings.

GCUD reserves the right at any time to connect more than one customer to a service line at any point between the main line and the meter.

I further agree that the installation of said service up to, and including the meter assembly, is a right of easement granted to the Utility District, and the title and ownership of said line and facilities shall at all time remain in GCUD and the same may be removed with or without cause at the discretion of the Utility.
